#### Shared Revenue: A Broken System for Critical Local Services

Wisconsin's levy limits and weakening shared revenues are depleting municipalities' ability to sustain police, fire, EMS, public works, and other essential services. Property taxes rise, municipalities take on more debt to get by, and budget cuts are more common than ever, putting a strain on the services they are able to provide. In short, the expenses keep going up, but the revenues are staying the same. The Village of Benton is no exception to this.

The message from the League of Wisconsin Municipalities is, "The system of paying for essential services is broken and it's up to the Wisconsin Legislature to fix it."

As a resident of our municipality, we need your help in reaching out to our legislators so they can hear our story. Without the help of legislation, we are facing the inability to afford rising fuel costs, road maintenance, and other adequate services for our community.

Between 2018-2019 in Wisconsin:

- 253 municipalities cut law enforcement funding
- 59 communities reduced number of officers on the street
- One in three municipalities cut back on fire protection
- State tax revenues have tripled in the last 30 years, but the share of those taxes going to support police, fire, EMS and other local services has gone DOWN.

#### THAT'S GOOD TO KNOW!

#### **Alternate Side Parking:**

Between November 1 and April 1, vehicles shall be parked only on the even numbered side of the street on even numbered calendar days, and on the odd numbered side of the street on odd numbered calendar days, between the hours of 12:00 AM (midnight) to 8:00 AM. (*Ordinance §320-12 (D*))

> \*No parking on Main Street from N. Van Buren Street to Bean Street 3 AM to 6 AM, year round. \*Easy Street parking on even side of the street only, year round.

#### Snow & Ice Removal:

All snow and ice should be removed from sidewalks within 24 hours of the most recent snowfall. If there is an area not being cleared within this time, please notify the Village Office.

#### Adopt a Fire Hydrant:

By removing snow and ice from around fire hydrants in your neighborhood, you can help make access easier for personnel in case of an emergency. Thank you for helping keep our community safe! The Village of Benton is excited to announce that we have been selected to receive a WI Department of Natural Resources 2023 Urban Forestry Grant for \$5,000!

This start-up grant covers a portion of the costs for removal, pruning and planting of trees in our parks. It is a great step toward improving our parks and recreation areas.
